<p>The Ministry of Education of Kenya received funding from the Mastercard Foundation to prepare a TVET Blueprint with the purpose to articulate a long-term strategic vision that will guide and influence reforms and development in TVET over the next 10 years (2020 to 2030). The Blueprint will seek to answer the central question: <i>‘What actions are needed to maximize the impact of TVET on skilling our people for greater socio-economic development’</i>. In addition to the TVET Blueprint (Part 1) also a National TVET Workforce Blueprint (Part 2) will be developed that will support and provide guidance to the National TVET Blueprint.</p> <p>Part 1- TVET Blueprint will consist of two phases. Phase 1 is the development of a concept paper that provides an overview of the different TVET stakeholders, main challenges, threats, strengths and opportunities that will allow for coherence amongst the stakeholders and which will also provide guidance and ownership to jointly determine the TVET priority areas for the National TVET Blueprint. Phase 2 includes the development of a National TVET Blueprint based on an in-depth TVET situational analysis.</p> <p>Part 2- TVET Workforce Blueprint is also consisting of two phases. First phase will be to prepare the economic outlook of the selected priority industries, to mention manufacturing, construction, agriculture and health.
