#### TERMS OF REFERENCE – PART A

Technical Assistance to the Africa Centres for Disease Control and Prevention (Africa CDC) Accreditation and Application to the Pandemic Fund

#### 1 BACKGROUND INFORMATION

The Africa Centres for Disease Control and Prevention (Africa CDC) is a continental autonomous health agency of the African Union established to support public health initiatives of Member States and strengthen the capacity of their public health institutions to detect, prevent, control and respond quickly and effectively to disease threats. Africa CDC works to build the capacity of public health institutions across Africa to strengthen the timeliness and effectiveness of public health responses.

As an integral part of the African approach to pandemic prevention, preparedness and response, the African Union and Africa CDC initiated Africa's New Public Health Order, which aims to set the course for how Africa deals with its public health realities. The New Public Health Order is built on five pillars, four of which all relate to the high-impact priorities set out in the Pandemic Fund, namely surveillance and early warning, laboratory systems and health workforce.

The Pandemic Fund is a multi-stakeholder global partnership, with its Secretariat hosted by the World Bank. The Pandemic Fund provides a dedicated stream of additional, long-term financing to strengthen pandemic prevention, preparedness and response (PPR) capacity and capabilities in low- and middle-income countries and to address critical gaps through investments and technical support at the national, regional, and global levels.

The Pandemic Fund launched its first funding round in January 2023, calling upon Eligible Countries, Regional Entities, and Implementing Entities to submit proposals for potential projects eligible for financial support. As a collaborative partnership facilitated by the World Bank and with technical leadership from the WHO, the Pandemic Fund involves donor countries, co-investors, foundations, and civil society organizations. The Fund's Governing Board has approved around \$300 million in financing for its initial round, aimed at strengthening countries' abilities to prevent, prepare for, and respond to future pandemics.

Africa CDC has expressed interest in applying for the Fund, leveraging its six years of operational experience to support member states in pandemic-related efforts. However, Africa CDC has not yet been accredited by the Pandemic Fund to be an Implementing Entity (IE), which is necessary for it to access this funding independently on behalf of African nations. Due to this, Africa CDC is unable to participate in the first call for Expressions of Interest, and Call for Proposals as well. There is increasing recognition of the importance of regional strategies and action on pandemic preparedness and response complementing the efforts at national level, and the mandates of regional institutions like Africa CDC is expected to be fit for purpose to serve as convening and coordinator of regional applications and actions.

To this end, this Technical Assistance support is required to support Africa CDC in the process of accreditation to be an implementing Agency and subsequently to support Africa CDC in preparing regional funding applications to implement actions under the Pandemic Fund.

  - Coordinate, lead, and support the drafting of the Africa CDC application to become an IE, ensuring compliance with Financial Intermediary Fund process and requirements.
  - o Provide detailed formulation of Africa CDC's role, complementarity, and support to the objectives of the Pandemic Fund.
  - o Identify and present relevant Africa CDC capabilities, procedures, and processes required for the application.
  - Identify potential supporters (optional, depending on self-submission or third party supported application).
- ➤ Requested services, including suggested methodology<sup>1</sup>
  - o To deploy one senior expert on a full time position for up to 6 months.
- Required outputs: The technical expert will deliver on the following outputs in line with specific tasks to be agreed with the Africa CDC:
  - Contribution to the operationalization of capacity building for Africa CDC systems in preparation for Pandemic Fund accreditation.
  - Preparation of a concise report presenting findings from the accreditation readiness assessment, along with recommendations and an action plan.
  - O Support in the development of proposal for potential projects, including theory of Change encompassing the entire project.
  - Comprehensive result management framework outlining expected outcomes and SMART indicators of progress for the entire project, along with separate or complementary result management frameworks for each country included in the proposal.
  - Overall risk framework that includes analysis of key organizational, institutional, and political risks, assessing likelihood and impact levels, and proposing corresponding mitigation measures for each risk.
  - Detailed list of proposed activities, with a timeline specified for each country included in the proposal.
