## TERMS OF REFERENCE – PART A

#### 1 BACKGROUND INFORMATION

Nigeria is the largest economy in Africa <sup>2,3</sup>, with an overall population of over 200 million, featuring 259 Universities hosting more than 1.95 million full-time undergraduate students in 2022, with natural and social sciences being the most common topics/ disciplines chosen. Headquartered in Abuja and with several campuses across Nigeria, the National Open University of Nigeria is the largest university in the country by number of students, with five hundred and sixty-five thousand (565,000) enrolled in 2019. It is also the largest open and distance-learning institute in the whole of Africa.

However, despite the numbers and the tradition of academic institutions in Nigeria, Nigerian participation in Horizon 2020 (H2020), the EU's Framework Programme for Research and Innovation, has been very limited, with only 30 participants (0.02% of the total) recorded over the seven years of H2020 implementation<sup>1</sup>. Also in Horizon Europe (HE), the current EU research framework programme from 2021 to 2027, it is evident that Nigeria is lagging behind compared to other countries in the region with only 28 participants having so far applied.

It is evident that Nigeria could benefit much more from Research and Innovation (R&I) investments to support the diversification of its economy, its advancement towards a knowledge economy and overall, to accelerate its sustainable development.

R&I cooperation between the EU and Nigeria was identified in the EU-Nigeria Ministerial roadmap of 18 November 2020 (since updated in January 2022) as one of the priorities for enhancing and deepening the overall cooperation between both sides. Accordingly, the roadmap identified a number of activities to be designed to improve the current level of R&I cooperation with the ultimate goal to significantly enhance participation of Nigerian academics and researchers in Horizon Europe (HE).

Horizon Europe, along with Erasmus+ - the EU flagship programme in support to education, are providing funding opportunities for Nigerian researchers and students to participate in European research and innovation projects and academic exchanges. In order to facilitate access to these opportunities, the European Commission has established a network of National Contact Points (NCPs): people nominated by the national authorities to provide free assistance and impartial advice to potential Horizon Europe applicants in their countries. The purpose of this contract is to establish and operate the NCP network for HE and Erasmus+ in Nigeria.

# 2 OBJECTIVE, PURPOSE & EXPECTED RESULTS

#### **➤** Global objective

This project aims to kick-start the establishment of a Nigerian National Contact Point (NCP) in the context of the EU's research and education programmes HE and Erasmus+. In accordance with the minimum standards and guiding principles for setting-up systems of NCPs under Horizon Europe<sup>2</sup>, a Nigerian NCP should:

- Be established, operated and financed under the Tertiary Education Trust Fund (TETFUND) in collaboration with the Nigerian Federal Ministry of Education and the Nigerian Federal Ministry of Science, Technology and Innovation, which will ensure compliance with the aforementioned minimum standards and guiding principles, including sufficient administrative capacity and performance monitoring;
- Be supported within its host organisation or by the national authority in terms of staff and equipment (e.g., IT) to a level commensurate with the scope of the mandate, and the size of the potential constituency. In this regard, TETFUND has taken an active role in unifying the views of both ministries and has a track record with the administration of the National Research Fund (NRF) programme for Nigeria. TETFUND has already appointed the different thematic NCPs and will host the website of the NCP network.

# > Specific objective(s)<sup>3</sup>

In order for the Nigerian NCP network to become operational, this support project should aim to:

 Provide an overview of the Nigerian Research &Innovation (R&I) system and all stakeholders and institutions involved. This will require among others to coordinate information gathering and consolidation of a fully comprehensive database with all State Governments and/or leading R&I institutions in the 36 States of the Federal Republic of Nigeria and the Federal Capital Territory.

Facilitate the elaboration, setting-up, and maintenance of a comprehensive database of public and private academic R&I institutions located in Nigeria. This would include the constant scoping of ongoing national (e.g., State and Federal) R&I programmes, stakeholders and infrastructures; to identify and leverage potential

synergies with HE and related or interconnected initiatives (e.g. future joint AU-EU Innovation Agenda).

- Develop a Horizon Europe and ERASMUS+ dedicated web portal, building on possibly existing national platforms as appropriate and making reference to the programmes official websites. The portal should include a link to EURAXESS<sup>4</sup>, to facilitate mobility opportunities. The portal will include relevant EU visual identity like EU logo, essential references, and clear links to all the relevant national support services (which may themselves be subject to distinct web sites). The applicants should consult the EU latest guidance on "Communicating and raising EU visibility" The portal will provide a single entry point for all participants and stakeholders, including SMEs and other businesses, and particularly those new to EU programmes.
- Provision of training to the recently nominated thematic NCPs for Horizon Europe. The aim is to ensure the NCP Network acts as multiplier/disseminator of information about HE, which should include the following;
  - i) General knowledge of Horizon Europe and its rules, principles and procedures;
  - ii) Handling of available online tools and databases provided through the European Commission
  - iii) Provision of information about calls for proposals under HE to potential applicants;
  - iv) Provision of regular updates concerning HE to the R&I community within the country.
- Facilitate the initial organisation and operation of the Nigerian NCP network, provide coordination and trainings and help ensure liaison with existing thematic NCP networks, and compliance with the minimum standards and guiding principles of NCPs.
- Organise several workshops (at least 10) on how to write a proposal for Horizon Europe topics, in particular those covered by the Horizon Europe Africa initiative II. Targeting the topics with achievable deadlines. i.e.; research topics or areas that should be completed within the stipulated time and don't run the risk of elongating beyond approved implementation period
- Organise HE National Info-days (physical and/or virtual) and matchmaking activities between Nigerian R&I institutions and potential EU partners in collaboration with EU member states representations in the country.
- Increase the participation of Nigerian academics and researchers in Horizon Europe and Erasmus+ through the provision of trainings and regular updates.

# ➤ Requested services, including suggested methodology<sup>5</sup>

The invited Contractors are asked to develop a methodology corresponding to the objectives and results described in these Terms of Reference. Contractors should propose assessments and analytical methodologies that will be used during the project implementation as part of their offer, which will be assessed during the evaluation of the offers. The methodology might be further adapted during the inception phase.

The assignment will require:

- Desk research.
- Interviews with key stakeholders (EU Delegation, EU Member States representations, TETFUND, Nigerian NCP network members, other NCP Networks supporting projects).
- Organisation of physical workshops, trainings and other events and when needed through online platforms.

Expected results are as follows:

#### **Result 1:**

Conduct a comprehensive analysis of the challenges and barriers faced by Nigerian researchers and academics in accessing and participating in Horizon Europe and Erasmus+ programs, and develop tailored solutions to address these challenges. This could involve identifying and addressing issues related to capacity building, infrastructure, funding, administrative procedures, and other factors that may impede participation, in order to maximize the impact of these programs and promote sustainable research and innovation partnerships between Nigeria and the EU.

#### **Result 2:**

Provide a fully comprehensive database for the coordination of information including Institutional Contact Points: the database of all stakeholders and institutions involved in the Nigerian R&I system.

This database should include NCPs at all State Governments and/or leading R&I institutions level in the 36 States of the Federal Republic of Nigeria, including FCT. This should be developed with inputs from the already established thematic NCP networks. This database will help to identify Institutional Contact Points. Institutional Contact Points are meant to be Horizon Europe and Erasmus + focal points in their institutions.

They will ensure the correct dissemination of information received from the NCP network to their respective institutions. They will establish close relationships with

applicants in their institutions and should be able to facilitate the organisation of workshops in their institutions when needed such as (providing a venue and infrastructure, gathering the needs in terms of training).

These institutions should include federal government research, science and innovation agencies. For example, National Agency for Science and Engineering Infrastructure (NASENI), Nigerian Institute of Medical Research (NIMR), National Space Research and Development Agency (NASRDA), National Biotechnology Development Agency (NABDA), National Centre for Agricultural Mechanization (NCAM) and Federal Institute of Industrial Research, Oshodi (FIIRO).

#### **Result 3:**

**Develop a dedicated web platform**: development of a web platform for the Nigerian National Contact Point (NCP) network for Horizon Europe and Erasmus+ programmes. The web platform should include essential references, and clear links to all the relevant national support services such as other national MDAs responsible for research and education in the country, providing a single entry point for all participants and stakeholders, including SMEs and other businesses. Highlighting, in particular, Nigerian entities participating to ongoing or past Horizon Europe/Horizon 2020 projects. For that purpose, the platform should link with existing available portals (i.e. Funding & Tender, CORDIS, Horizon Europe NCP network Portal, etc.). The website should include elements from the other expected results (access to database, stakeholder analysis and training material).

#### **Result 4:**

Training for the NCPs: The provision of training to the recently nominated thematic NCPs for Horizon Europe as well as NCPs at institutional level. This training should aim at ensuring that the NCPs act as a multiplier and disseminator of information about Horizon Europe. The training should also help participants get familiar with rules and procedures, available online tools and databases provided through DG RTD, provision of information about calls for proposals under Horizon Europe to potential applicants, and provision of regular updates concerning Horizon Europe to the R&I community within the country.

#### **Result 5:**

**Organisation and operation of the Nigerian NCPs network**: in collaboration with the national NCP Coordinator, work with national authority(TETUND) in the initial organisation and operation of the Nigerian NCPs network, providing coordination and training where necessary, and helping to ensure liaison with existing thematic NCP networks, and compliance with the minimum standards and guiding principles.

#### **Result 6:**

Workshops on writing proposals: the organisation of several workshops (at least 16) within the three years of the project on how to write proposals for Horizon Europe topics, in particular those covered by the Horizon Europe Africa initiative II<sup>6</sup>. These workshops should target topics with achievable deadlines, to help increase the participation of Nigerian academics and researchers in the Horizon Europe programme. An initial set of participants has been identified by TETFUND that should be used as a starting point.

It can be useful to determine which universities/institutions have facilities that can accommodate workshops. The size of the venue, the availability of necessary equipment, and the potential audience size should be considered. For that purpose, there should be synergies between the Institutional Contact Points, and the thematic National contact point. The contractor is encouraged to liaise with EU and its Member States representations in Abuja in order to identify, European researchers and/or Horizon Europe grantees willing to complement the workshop through online participation.

When selecting topics for training workshops for Nigerian applicants, it is important to consider the cut-off date of the various call for proposals under HE and particularly those that will close under the second African initiative. In particular, it is important to consider the areas where Nigeria has a competitive advantage, as well as the country's development priorities. Subject to prior check with TETFUND, some potential topic areas that may be relevant for Nigerian applicants may include (but not limited to):

- Agriculture and food security: Nigeria has a large agricultural sector and is a major producer of crops such as cocoa, cassava, and yams. There may be opportunities to develop research projects and collaborations related to improving crop yields, increasing food security, and developing value-added products from agricultural commodities.
- 2. Renewable energy: Nigeria is a major oil producer, but there is also significant potential for renewable energy development in the country. Topics related to solar, wind, and bioenergy could be relevant for training workshops.
- 3. Health and biomedical research: Nigeria faces significant health challenges related to infectious diseases, maternal and child health, communicable and non-communicable diseases such as diabetes and hypertension. Research projects related to these areas could be developed in collaboration with Nigerian universities/research institutions e.g., NIMR. The application of emerging e-health/digital technologies to enhance reaching more vulnerable rural communities should also be of interest.
- 4. Water resource management: Nigeria faces water resource management challenges, including access to clean water and flooding. There may be opportunities to develop research projects related to water resource management and conservation, including wastewater management.
- 5. Information and communication technology (ICT)/ Digital services: Nigeria has a large and growing ICT sector, with opportunities for research and development in areas such as cybersecurity, e-commerce, agri-tech, e-health, and data and data analytics.
- 6. Space: There are various areas within the space sector that could be of interest, such as, Earth observation, satellite technology, space science, space policy and governance. In recent years, Nigeria has launched its own satellites and established a national space agency, the National Space Research and Development Agency (NASRDA), which could be a potential partner for collaboration and capacity building activities. Therefore, training workshops on space-related topics could also be valuable for Nigerian universities and researchers.

These are just a few examples of potential topic areas for training workshops in Nigerian universities. Ultimately, the topics selected should be based on a careful assessment of Nigeria's needs and priorities, as well as the expertise and research interests of the universities involved.

#### **Result 7:**

Organise Info-days and Matchmaking activities: the organisation of Info-days and matchmaking activities between Nigerian R&I institutions and potential EU partners in collaboration with EU member states in the country. These activities should be designed to help increase participation of Nigerian academics and researchers in the Horizon Europe programme. This will help identify and leverage potential synergies with Horizon Europe as well as related or interconnected initiatives, such as the future joint AU-EU Innovation Agenda.

#### **Result 8:**

Work with EUD communication and visibility contractor to develop a targeted communication and outreach strategy to raise awareness and promote the benefits of Horizon Europe and Erasmus+ programs to Nigerian researchers, academics, and students. This strategy could involve leveraging existing networks, partnerships, and collaborations, as well as creating new ones, to reach a wide audience and generate interest in participating in these programs.
